<u>APPLICATION TO BECOME AN APPROVED MEDIATOR</u>

To be approved as a mediator, you must meet the following qualifications and agree to be bound by the following:

- 1. Mediators must be lawyers, licensed to practice in the State of Tennessee and admitted to practice in the United States District Court for the Eastern District of Tennessee;
- 2. Mediators must have practiced law at least five years;
- 3. Mediators must have had at least forty (40) hours of formal mediation training as approved by the Court¹ and such procedural training as shall be provided by the Clerk of the Court.
- 4. Mediators must report the results of their mediations in accordance with Local Rule 16.4(m).
- 5. Mediators must be available to conduct at least one mediation per year without compensation.
- 6. Mediators must commit to at least one year of service on the Mediation Panel.
- 7. Mediators must participate in any reporting and research requirements of the program.
- 8. Mediators must comply with the provisions of the program as set forth in Local Rule 16.4 and any applicable Standing Orders.
- 9. Mediators must provide the Court with such biographical information that the Court may require that will be made available to litigants and lawyers who are seeking mediators.

¹ The Court will accept mediation training approved by the Tennessee Commission on Continuing Legal Education and Specialization; the American Arbitration Association, Dispute Management, Inc.; Mediation and Conflict Management Services of St. Louis; United States Arbitration & Mediation or equivalent training as determined by the Court's **Standing Committee to Administer ADR Programs**.
