The United States District Court for the Eastern District of Tennessee will upgrade CM/ECF to Next Generation CM/ECF (NextGen), on December 6, 2019.

The CM/ECF system will be unavailable from 12:00pm (noon), Friday, December 6th, until 8:30am, Monday, December 9th. Beginning on December 9th, use your upgraded PACER account credentials to log in to file and/or view documents in any NextGen CM/ECF court.
