STANDING ORDER

Pursuant to 28 U.S.C. § 137, it is hereby **ORDERED** that:

1. In the event that an application for writ of habeas corpus pursuant to 28 U.S.C. § 2255 is filed after entry of this Order in any closed criminal case currently assigned to Senior United States District Judge R. Leon Jordan, both the application for writ of habeas corpus and the underlying criminal case will be **REASSIGNED** randomly to United States District Judge Thomas A. Varlan or United States District Judge Katherine A. Crytzer for cases pending in the Northern Division; to Chief United States District Judge Travis R. McDonough for cases pending in the Southern and Winchester Divisions; and to United States District Judge Clifton L. Corker for cases pending in the Northeastern Division.

2. Any closed criminal case currently assigned to Senior United States District Judge R. Leon Jordan in which any motion is filed after entry of this Order, with the exception of motions for early termination of supervised release, will be **REASSIGNED** randomly to United States District Judge Thomas A. Varlan or United States District Judge Katherine A. Crytzer for cases pending in the Northern Division; to Chief United States District Judge Travis R. McDonough for cases pending in the Southern and Winchester Divisions; and to United States District Judge Clifton L. Corker for cases pending in the Northeastern Division. Any closed criminal case currently assigned to Senior United States District Judge R. Leon Jordan in which the United States Probation Office seeks guidance or action related to any person under its

supervision after entry of this Order will remain assigned to Senior United States District Judge R. Leon Jordan.

3. Any closed civil case currently assigned to Senior United States District Judge R. Leon Jordan in which any motion is filed after entry of this Order will be **REASSIGNED** randomly to a district judge in the Court's civil case rotation.

4. Any civil case currently assigned to Senior United States District Judge R. Leon Jordan that is remanded by an appellate court after entry of this Order will be **REASSIGNED** randomly to a district judge in the Court's civil case rotation.


5. Any criminal case currently assigned to Senior United States District Judge R. Leon Jordan that is remanded by an appellate court after entry of this Order will be **REASSIGNED** randomly to United States District Judge Thomas A. Varlan or United States District Judge Katherine A. Crytzer for cases pending in the Northern Division; to Chief United States District Judge Travis R. McDonough for cases pending in the Southern and Winchester Divisions; and to United States District Judge Clifton L. Corker for cases pending in the Northeastern Division.

6. Any closed civil case currently assigned to Senior United States District Judge R. Leon Jordan that is, for any reason, reopened after entry of this Order will be **REASSIGNED** randomly to a district judge in the Court's civil case rotation.

7. Any closed criminal case currently assigned to Senior United States District Judge R. Leon Jordan that is, for any reason, reopened after entry of this Order will be **REASSIGNED** randomly to United States District Judge Thomas A. Varlan or United States District Judge Katherine A. Crytzer for cases pending in the Northern Division; to Chief United States District

Judge Travis R. McDonough for cases pending in the Southern and Winchester Divisions; and to United States District Judge Clifton L. Corker for cases pending in the Northeastern Division.
