Ordinary Transcript (30 day) A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$3.65	\$.90	\$.60

The Judicial Conference has approved an increase to these maximum rates to take effect for fiscal years 2024 and 2025. JCUS, Report of the Proceedings, Sep. 20, 2022. Upon these increased rates taking effect, the Court hereby automatically adopts these rates as the maximum transcript rates without the need of any further order.²

In addition, the Court deems \$225.00 for one-half days, \$450.00 for full days, and \$60.00 an hour for time expended after 5:00 p.m. to be reasonable maximum attendance fees. Those sums are the maximum attendance fees payable by the Court for contract court reporters unless approved by the Clerk of Court. Clerk approval of attendance rates in excess of these maximum rates should be obtained in advance of the provision of the service. Those sums are also the maximum attendance fees taxable as costs under 28 U.S.C. § 1920 and E.D. Tenn. LR 54.1.

Transcripts of *voir dire* proceedings shall be transcribed only if the appropriate section of the transcript request form is completed. If a transcript of *voir dire* proceedings is requested,
