IN ORDER TO BE APPROVED AS A MEDIATOR IN THIS COURT,
YOU MUST MEET THE FOLLOWING QUALIFICATIONS AND ALSO AGREE TO
BE BOUND BY THE FOLLOWING:

1. All mediators must be lawyers, licensed to practice in the State of Tennessee and admitted to practice in the United States District Court for the Eastern District of Tennessee;
2. All mediators shall have practiced law at least five years;
3. All mediators shall have had formal procedural and substantive training, including at least forty (40) hours of formal mediation training as approved by the Court. Procedural training shall be provided by the Clerk of the Court.
4. Mediators must report the results of their mediations in accordance with Local Rule 16.4(m).
5. Mediators shall agree that they will be available to conduct at least one pro bono mediation per year.

6. Mediators shall commit to at least one year of service on the Mediation Panel.
7. Mediators shall agree to participate in any reporting and research requirements of the program.
8. All mediators shall agree to comply with the provisions of the program as set forth in Local Rule 16.4, EDTN (copy attached).
9. All mediators shall agree to provide the Court with biographical information that the Court may require that will be made available to litigants and lawyers who are seeking mediators.

YOUR APPLICATION WILL BE REVIEWED BY THE COURT'S STANDING COMMITTEE ON APPROVAL AND EVALUATION OF MEDIATORS. MEMBERS OF THIS COMMITTEE ARE MAGISTRATE JUDGE SHIRLEY, MAGISTRATE JUDGE CORKER AND MAGISTRATE JUDGE STEGER. YOU WILL BE NOTIFIED BY A COMMITTEE MEMBER OF ACTION TAKEN ON YOUR APPLICATION. IF YOU ARE APPROVED, PROCEDURAL TRAINING WILL BE PROVIDED BY THE CLERK OF THE COURT.
