O R D E R

Pursuant to 28 U.S.C. § 631(a) and actions taken by the Judicial Conference of the United States in March 1987 and March, 1992, the full-time United States Magistrate Judges sitting at Knoxville, Tennessee, are hereby authorized to serve in the adjoining Eastern District of Kentucky and Middle District of Tennessee for the purpose of carrying out the duties specified in 28 U.S.C. § 636(a) and 18 U.S.C. § 3401 to the extent that such duties are exercised in connection with matters arising from the operation of the Big South Fork National River and Recreation Area.


The Clerk of the United States District Court of the Eastern District of Tennessee shall forward a certified copy of this Order to the Director of the


