In 2012, Chief

Judge Thomas A. Varlan created a Community Outreach Programs Committee to coordinate the Court's various outreach efforts. The following are some of the programs currently offered.

#### Open Doors to the Court

Open Doors to the Federal Courts is a national program, which welcomes students into local federal courthouses around the country. The objective is to bring high school students, teachers, judges, court staff, and local lawyers together to enhance public knowledge and understanding of the federal court system. The program is intended for high school students (generally juniors and seniors) who have studied civics or United States government. The students and their teachers are invited into the courthouse to participate in a scripted mock trial program.



#### Constitution Day Activities

#### Judges in the Classroom

The judges of the Eastern District of Tennessee travel to give presentations to local scout troops working on their citizenship merit badge, they serve as mock trial judges for area schools and universities, serve on question and answer panels for schools, civic groups, professional groups, and bar associations, and also conduct classroom type training in the courtroom. Constitution Day activities are held in the courtroom where students play the role of characters in a skit and other students respond to trivia questions. The judges who participate in these programs strive to encourage students to embrace the concepts of justice, to clarify the roles of the individual in a free society, and to convey the message that hard work in school will achieve success. The judges believe that if we can provide a positive influence, even in a small way, which leads to success of students in our schools, our communities will reap the benefits in the future.







#### Courthouse Tours/Visits

The Community Outreach Programs Coordinator or Division Representative can arrange for a visit to the federal courthouse in your area. The visit can include a tour of the courthouse, observing a court hearing, a presentation by one of our judges, a presentation by federal law enforcement and court personnel sharing an overview about their jobs, and much more.
